Not many recent updates. Since last meeting Coast Guard issued West Sound Marina an order to put together a plan to monitor and manage sheen, they did and it was approved. With Legislature going into session, DNR will seek more funds for their Derelict Vessel (DV) program. We want to take advantage of that, looking into costs and trying to put together proposal(s) to lift and move it. Support from Debra Lekanoff. Trying to be creative No reconvened meeting of all agencies, probably will be soon. Still no determination of owner(s) or liable party.

9:39 AM Spring Vessel Turn-in event

Adam & Kari working with NW Straits DV work group, helping to prioritize vessels and events. Multiple partners. We have brochures, applications due by March 1. Taking 12 vessels maximum but accept as many applications as possible - this will help us know where vessels are and identify for prioritization. At the event, limited to a week at the yard to decommission/deconstruct. Working with DNR to do more events in future. If successful, could be annual. Brochure going out with invoicing to Port customers and shared with other marinas. This is federally funded, NOAA and Seagrant money coming from DNR. Tentatively planning for April 12th, it's a time of year when we have enough yard space but want to keep dates off the brochure. Must apply and if approved, a date will be given to bring the boat at that time. Also applies to boats sitting in yards because people often get rid of those by pushing them into the water. Dave: maybe a meeting where everyone is present and learn in general about the issues. I'd like to be involved Frankie: Seattle Boat show in Seattle February 1. Whale Museum just hired a new Soundwatch coordinator. NOAA offered to run the Boat Show outreach this year. Plan to meet about this soon, great for any MRC members to volunteer. Expenses covered (by Whale Museum). Working with Katie to get information out to MRC members. Grant round kicked off. Sam sent out materials. Letters of Interest (LoI's) due February 18th, project sponsors will meet with TAG in March. This will be a big grant round. May site visits. Sam will keep everyone updated. TAG members are required to attend site visits, MRC members are strongly encouraged (sometimes there are space limitations due to space on boats) Block out May 1 and 2, we'll be going out and looking at projects.

10:29 **Presentation**: San Juan County Salmon Recovery Program Overview *Sam Whitridge* Request at Retreat to review technical priorities in the Salmon program, science behind how we select projects; SJI's in the heart of Salish Sea, map produced by Friends shows 22 stocks of chinook that pass through to the ocean. Limited spawning, but big feeding stopover for migrating juveniles. How to select projects in right places: Beamer and Fresh (2011) study provided a probability index for finding a juvenile chinook. Places with highest probability are south Lopez, and N. Waldron, President channel area. Based on that study, County and Lead Entity worked with Friends of San Juans and other technical experts to create the PIAT (Pulling it all together) report, PIAT I in 2012 was a shoreform and landscape-scale prioritization study; PIAT II in 2017 refined previous studies down to parcel and project scale. Identified areas as priority fish use regions shown on map: Waldron/President channel, Rosario SW, Juan d Fuca/S. Lopez, and Haro Strait NE. Map shows priority fish use areas by shoreform, table of shoreform types in highest priority use regions (i.e. pocket beach, feeder bluff, etc.)

We've discussed and identified protection as top local priority, restoration is second priority, and assessments are third because protection is most cost-effective, easier to protect before degradation than to restore, and more ecologically successful than restoration. Protection refers to acquisitions and conservation easements, those are protected through perpetuity, but restoration projects have a 7-year time frame within this grant process. We have a lot of high-quality habitat in San Juan County identified as in need of protection.

Dave: does protection mean protection of forage fish as food for salmon?

Sam: yes, forage fish and also habitat that's good for salmon rearing. The main factors of juvenile chinook rearing and forage fish spawning/rearing (herring, sand lance, surf smelt) combined make up fish use priorities.

We don't do dock removal projects for salmon recovery projects, just too big for us too tackle

Sam: in 2022 finalized Salmon Recovery Chapter Update, our local chapter for the NOAA chinook salmon recovery plan. Includes 15 different regions with lead entities, each provided their own local priorities chapter.

First chapter established in 2005, first NOAA recovery plan in 2007. Now all subsequent studies (like the Beamer and Fresh and PIAT, etc.) fed into our local salmon recovery chapter update. This is our guiding document. Completed through a two-year process started in 2020, committee of TAG and MRC members, project sponsors, agency members etc. Some funding from Puget Sound Partnership and ESA. This document is available online. How it's structured: established 50-year goals and 10-year targets for nearshore habitat types (6 different types) We also have Freshwater goals and targets for specific habitat types (like Cascade Creek that has spawning salmonids). These goals are more qualitative, further data needed to refine further. Identified 8 watersheds (on SJI and Orcas) we want to work in where we have the most data and background. We address restoration and protection strategies for salmon recovery through the Grant round, annual SRFB and biennial PSAR funds. Process is locally driven by TAG and CAG scoring and ranking projects, then a regional and statewide process.

We are one of 15 lead entities around Puget Sound. That term refers to the local salmon recovery process. In that role we participate in various regional and statewide processes.

Sam encourages everyone to review the salmon recovery chapter update doc as well as the PIAT I and II studies. ACTION ITEM: Sam can send out these slides and links to the documents just mentioned to all members

9:05 AM NWSC Meeting Report to the MRC

Karin attended. We still need additional kayak monitors for kelp monitoring and also volunteers for green crabs. Jeff has been a kayaker volunteer for several years on Lopez. No green crab reported so far around Lopez or on SJI. Brian: I'd like to learn more about how I can participate as someone who's on the water a lot

Frankie: Samish already does kelp monitoring; we should ask NW Straits where to monitor, not duplicating efforts Sasha: Counties who have established sites may be seeking additional help, Jeff Whitty would be the person to ask ACTION ITEM: we'll circle back to Brian G. about how he can help

Brian: if we need a representative on the ground, coordinating efforts on the water, maybe I can connect with Jeff Frankie: We have a green crab site on SJI at Westcott Bay, Jess Newley and Katie Foster have been in charge of that, effort run by the green crab team. If people are interested in helping they should contact them for training Laura Jo: we don't look for green crab in a kayak, it involves walking into water with high boots to pick up traps Dave Checkley: I'm interested in helping, need more information about timing commitment

9:14 AM Presentation: False Bay Nutrient Study

Sam's presentation: Unraveling marine and terrestrial nutrient interplay at False Bay. Sam thanks his advisors, Drs. Brooke Sullivan and Wendel Raymond. Green algae growing season starts in March, peaks in mid-summer. Questions about whether agricultural activities in the watershed are affecting algae growth. How does nutrient input from the Creek affect the formation of the green tide, Ulva spp., in False Bay? Methods included sampling water and algae biomass. Results showed seasonal patterns in algal abundance peak in August or September. Clear seasonal pattern with higher precipitation in the fall and winter months with some sporadic high precipitation events and lower in spring and summer with sometimes no precipitation at all. Water flow can slow/stop in spring and by summer. Salinity was stable at nearshore location, but at creek mouth when there's no freshwater available there are clear marine signals. Beyond general seasonal pattern, there were also patterns in specific nutrients (Sam describes these in detail).

Isotope analysis – comparison with a study from Penn Cove which looked at seasonal variation in algal mats. In our study, samples taken in May and November suggest that green algae at False Bay are using marine origin water for nutrients, but still need more samples for definitive result. For future research, certain areas of False Bay should be sampled further. Look closer at groundwater sources particularly with concerns about agricultural

influences. Some points within False Bay could be emerging groundwater where we may see more stable populations of green algae

QUESTIONS

Karin: with this information, how can we expect climate change to make this worse? In what way? Sam: drier summer, climate change could reduce the water level in the Creek and flow earlier in the season, possibly more tidal intrusion into groundwater, groundwater may be a bigger nutrient contribution into False Bay Karin: then how can we use this information? how else can we make changes?

Sam: potentially better agricultural land management. Could put monitoring equipment into the Bay and Creek Wendel: these data are available here, <u>https://knb.ecoinformatics.org/view/doi%3A10.5063%2FF1KD1WBG</u> Still more work to do to investigate the groundwater contribution question

Craig: is it more Nitrogen or Phosphorus limited?

Sam: it's phosphate limited now, Salish sea itself is nitrogen rich compared to other parts of world Lovel: are there ag best practices that would make a significant difference, and how to mandate best practices? Kim: CWAC has been looking at impacts to False Bay watershed for years, including how to implement BMP's (Best Management Practices). Working with Red Mill Farm through SJPT (800 acres of ranch land used for cattle grazing) and Land Bank which acquired Zylstra Lake property. VSP (Voluntary Stewardship Program) hasn't done enough to mitigate impacts so we've worked on grant funding to fence cattle out from creeks. With help from partners, we've fenced about half of the length of the Creek now, working on funding to fence the rest and then invest in restoration.

Dave: hypothesis that fertilizers cause Phosphate to come into False Bay or is it about production from cattle? Wendel: the original question was about the drainage of land around the Creek causing a notable nutrient signature in False Bay. Ulva thrives in high nutrient environments. These data suggest it could be largely just a shallow open bay, a nice place to be Ulva. Teasing apart Nitrogen and phosphorus sources would require much more isotopic analysis

Kendra: mainly it's preventing cows' poop in creek drainage, there aren't good BMP's to manage the bacteria load Kim: there is high phosphorus detected in Zylstra Lake. The result has been some toxic algal blooms. Sam's study brought up this question of groundwater and how that may drive the system when Creek drops in summertime.

9:50 AM MRC Updates/Business

• Emergency Response Towing Vessel (ERTV) Outreach Update Sam Whitridge ERTV has been looking at the Ecology report to highlight buried information we felt was important to the conclusion of the analysis. Our intent was to draft a letter to Governor Inslee. We met with Inslee's top policy advisor. She was clear the governor's office is not interested in compelling Ecology to revise the report. She suggested focus on moving forward with policy steps to get the ERTV positioned in inland waters. We've worked on a one-pager to send with Cindy Wolf to DC for when she meets with Senator Cantwell's staff, continue to highlight gaps we see in the report. Marta has put in a lot of time in on this, she was instrumental in drafting that one-pager. Kendra has been working with Cindy

Frankie: has the County's analysis of this been shared with Tribes or with NWFC (NW Fisheries commission)? Marta: yes, and this one pager we've developed is a good tool to get our message out, I'd be glad to share it. But I'm not yet giving up on changing the Ecology report. I think we need to continue to raise the concerns about it. Kendra: If Ecology won't revise report, we can blow past and share data as we see fit with Tribes and whomever. Craig: I agree we must go to the next step regarding the conclusions. The main point is that we need an ERTV in Roche or Sydney. That Ecology report is ludicrous; let's just bypass it and push our main conclusion. As the MRC advisory body, not the County, and maybe with other MRC's and NWSC support those short couple of points. Marta: there was a significant reduction in their risk analysis for benefits of an ERTV in Sydney, but that's an error. Lovel: we need to take up Ecology's offer to confirm the data and correct the analysis for Sydney. Need to meet again as a subcommittee and review how to undertake that communication with Ecology. Transport Canada is in the process of writing the report about their version of an ERTV, due this spring, important for them to get these revised data ACTION: Sam will schedule a subcommittee meeting, take up Brian Kirk at Ecology on his offer for correspondence

We've had an offer to pay for the Jackson Beach project that's underway. MRC will close out its grant as planned and there will be a funding swap, then those NOAA funds will be available again for another project in 2024 Kendra: Has there been discussion of using that money to advance the vessel monitoring/benthic impact project? Craig: the habitat survey with Greene, can we extend to other areas like northern parts of SJI and Stuart?

It's a one-day event to meet with legislators and communicate priorities including funding for projects; removal of "match requirements" that create an administrative burden, especially a barrier to state funds for smaller organizations; and improved coordination/streamlining of the permitting process. Hope to reestablish this as an annual event.

Sam shares screen to show important dates. Letters of Intent have been sent out. March 6 – TAG meet to review Letters of intent. May 1-2 site visits; typically, these replace the regular May MRC CAG meeting. Then TAG meets again May 15 and June 27. CAG will do its final scoring at the regular August 1 meeting. This is a big year in terms of funding, still a moving target for final amount – Sam reviews details, combined total a little under \$2 million

10:40 AM • Re Agate Beach PSAR Project

The project depended on moving the road, Public Works still struggling to do that. Design completed BUT with latest storm events, bluff and road have eroded. We may not be able to provide beach access at Agate anymore. The road has not yet been moved. So, we propose to turn back in construction funds so that money can be used for other projects. We'll shelve the permits and the design and circle back in future. We plan to talk more about managed retreat and inundation effects on over 13 miles of infrastructure. We've recently completed a sea level rise study looking at some of these key areas and finishing up County mapping to show effects of sea level rise We'll need to talk with our lawyer about how to communicate this to the public, what we can and can't do Karin: we toured this area a few years ago, there was concern at that time about peoples' septic systems Kendra: in this particular section of Mackaye, septics are still intact. Road is still there but it's down to one lane. But there are other areas, like Port Stanley, where inundation will make it challenging for systems to operate

10:46 AM • Discussion on how to allocate PSAR Return Funds in San Juan County Sam Whitridge Talking with Kat Moore, our grant manager, about the \$316K allotted to that project. We have an option to keep those funds in the region for a salmon recovery project but short window of time because these are 2021 PSAR funds that expire sooner than current round of funding, sooner than a new project would be ready to move them. Need a project that's ready to pounce now and those funds go back to the Partnership. There is an immediate need now with the CD.

We were initially only able to partially fund the initial ask for CD eelgrass project. First step we could take now is to make their project whole, plus additional costs. No other active salmon recovery project has an immediate need Kendra: Frankie may have an additional need on Weeks Way

Frankie: haven't had a chance to look into it yet but likely we'll need to increase our budget.

Why wasn't cultural resources review study incorporated into original budget? What are concerns from Tribes? Mitch: These funds are not for cultural review, these are just to complete our original request. The reason the cultural review was unforeseen is because of an extensive request for subtidal archeological surveys to be done for each of our planting sites. These areas have been identified as close to culturally sensitive areas. Federal funding may be able to compensate for some of that. This is in very preliminary planning stages

Frankie: where is your planting site at Jackson beach? Please coordinate with us and our restoration site MOTION: Dave Checkley moves to approve request for CAG to make CD eelgrass project budget whole, Kendra seconds. Everyone approves, the motion passes

Sam: and for the additional funding, whether it goes to Mitch for CD project or to Frankie for Weeks, I'll just need to complete paperwork for the cost increase form with Kat. It'll need to be allocated pretty soon Jeff: do these funds need to be in alignment with original grant proposal or can it be supplemental? Sam: if it's just a cost increase on an existing project because of new expenses, then it's straightforward CAG approval. IF there's a change in the project scope or design, needs to go through TAG for approval. Jeff: other projects from last year are going ok?

Sam: Sorenson project has had a lot of additional archeological costs, still no exact amount request ready. Nothing else imminent in terms of extra costs from Tina or Friends.

9:09 AM **NWSC February Meeting Report to the MRC**

A rep from Patty Murray's office attended and gave some news, the NWS is kicking off a DEI assessment and Christina will participate, the 2023 impact report was released last week – Christina will make sure MRC gets a copy. Next conference will be November 15-16 in Snohomish, seeking people to serve on planning committee. May -16-17 is Puget Sound Day on the Hill. The NWSC approved adding a second Tribal seat. A new funding tool online.

9:14 AM Presentation on proposed kelp farm pilot project

Linda Degnan Cobos Linda introduces colleagues Sean Wilson, Mark Donahue. We've had a project garden at the local school for past decade. Now looking for a local site for a kelp project in part of Jackson Bay – Sean is a landowner there. We're looking for a site that already had DNR permitting. Sean is also interested in regenerative programs Sean: I like the idea of lessening our impact on the world by growing kelp, specifically interested in Mark: I applied for aquatic farm permit for seaweed in 2015 and shot down. I've been involved in Alaska shellfish aquaculture. It's a misnomer that our plans are industrial, more restoration minded. I've been helping with seasonal strings and growth. I'd like to see this as a demonstration project at Jackson beach.

Linda: We attended a Seagrant training - learned that kelp forests have been disappearing all along west coast. In the Salish sea, Samish and some others are looking at kelp, trying to map out historic and present kelp beds. In our Seagrant training, learned about permitting necessary due to multiple interests, how to apply for a JARPA permit. Kelp can sequester carbon, improve habitat and increase oxygen, decrease acidification. There's a group that's helping establish kelp farmers, they have plans available online for creating a small container lab, we're interested in exploring that. Aim to put in on the other side of where the barge-launching operation goes. We're making connections with the different agencies we need to get in touch with, creating a business plan. After harvesting, want to use kelp in soil amendment for agriculture. There's a market for it, it helps plants grow, great for mulch. Following Seagrant training, developed a WA seaweed collaborative, meet quarterly, the membership is 300 people, includes connections with consumers who want to use kelp as a crop amendment.

Mark: research from Maine shows thicker mussel shells inside kelp farms vs. outside. Hope this can be an oasis for of improved habitat. Also, there are techniques to avoid entanglement from marine mammals, that's a top priority.

Linda describes kelp operation: a couple of anchors (a helical screw instead of concrete) and then series of a few vertical and horizontal lines, weights added once kelp begins to grow; the only appearance at the surface is buoys. There's support from Puget Sound Restoration Fund, Seagrant, and similar efforts on Lummi and Hood Canal. We're talking with various entities, trying to move it all forward simultaneously and we wanted to make this group aware.

QUESTIONS

Craig Smith: how much is this mimicking the ephemeral nature of kelp beds? And when you're selling carbon sequestration, must consider the scale needed to affect it and how that would affect the marine ecosystems. AND about idea of use as fertilizer, then it's not going to store carbon because it'll go into respiration, but can it replace very fuel-intensive fertilizing alternatives?

Linda: the area we're talking about is Jackson Beach, old charts show kelp beds there. The psori we're going to take will be local so we have the best chance of preserving local genetic divert and survival. As far as using kelp as crop amendment, there's a lot of research on how they benefit crops, various methods. It can replace fertilizers, doesn't sequester carbon, but grows fast and gets consumed fast so it gets integrated in the food chain. Not trying for carbon credits but will be a benefit. Linda points to more research on benefits of kelp as a crop/soil amendment. Kelp is a filter feeder, benefits surrounding shellfish, when there are too many nutrients and acidification it can improve habitat, we'll be growing it, harvesting it and then it'll produce more spores and we'll re-grow ACTION: Linda can provide that research to Craig

Sean: as far as not having an effect if it's not large scale, I think you can start small and be an example. If we can make it cost-effective and duplicable, and then we can find historical kelp bed locations and replant, that'll be great.

As far as the crop supplements go, having them for cattle and livestock, so we either eat less cows or else feed them something that produces less methane, maybe we'd only make enough for local cows

Craig: when you talk about sequestration you need to consider what it means at scale even if you start locally Cindy: Mark, you may remember that we worked together on the idea of kelp at Orcas back in 2019. That was left in the permitting process. So does this JARPA take you through Tribal consultation?

Linda: we're doing outreach on that now. Looking at who has domain – Lummi, Tulalip...total of 14 tribes. Making contacts in the different Tribes and nations to hear concerns, check interests in partnering, etc. We're talking to Frankie as a resource. Starting small and not bite off more than we can chew and then scale up

Frankie: we're not talking about the Public Works part of Jackson beach, we're talking about a cove to the east, be aware there is eelgrass between those two points (and some specific advice about approaching Lummi) Kendra: you should ask advice of Council, there's a lot of activity down there, existing barge landing and they're trying to pursue a hardened barge landing, and a large amount of restoration work

Question to Cindy, should this body make a recommendation to Council? Share what's going on and get direction? We as staff should know how to advise them and how frequency of barge landings gets considered.

Cindy: makes sense to get authorization from Council to use some county resources for some research into this. MOTION: Lovel moves we request staff coordinate with Council regarding all the different work proposed and the partners proposing the work at Jackson beach and come up with a management plan. Sandy seconds, no further discussion, all in favor, none opposed. The motion carries.

9:55 AM **MRC Updates/Business**

 MRC interest in restarting kelp kayak monitoring program Some discussion over last few weeks about NWSC kelp kayak initiative, Phil Green was the lead for some years and program stopped partly due to amount of kelp in the SJI's. And Samish is doing some research on kelp as well. Now Brian and Jeff are both interested and ready to relaunch the program. We'd need to think about what we hope to achieve. Coordinate with Samish to understand where they're monitoring

Brian: I'm happy to be part of restarting this, I just don't know all the details about what's already being done so didn't want to start something that would be redundant or that wouldn't be helpful. Happy to restart with Jeff

Sam Whitridge/Brian Goodremont

Frankie: I suggest coordination with Samish nation and DNR to identify sites that would be helpful to them for you to monitor. Intensive monitoring at some sites rather than wide net would likely add/contribute to what's going on Phil was only doing this at one small site to monitor the impacts of development at Deer Harbor (the bridge there) Kari: years ago, we talked about doing a citizen science thing using commercial kayak groups, we've done that before on the west side of SJI. If we were doing a comprehensive area maybe other companies would also want to get involved as a community service work. That was part of KELP (Kayak education and leadership Program) Kailey: are surveys counting species?

Frankie: it's percent cover and then some specific protocol from NWS that would be followed Aaron: can we get a short description of what the past efforts looked like on the ground? Sam: it was really just focused around Deer Harbor looking at any silting impacts around there. Just 2-3 sites near there. Can vary in terms of timing. We could tailor it to sites and the frequency of monitoring Brian: paraphrasing Phil, he said the survey he was doing represented less than 1% of kelp in SJC ACTION: Sam will connect partners in the structure, make sure Jeff Whitty and the Samish are partnered up Brian: and I'm happy to engage some of the other companies like you suggested Dave: any aerial surveys done?

Kendra: good question, we're trying

Cindy: on the eelgrass, there was a presentation from the Samish at the ECB of drone aerials for eelgrass Dave: I thought data existed of aerial views, getting a true picture of kelp beds might require an effort of that scale Sam: it would be mapping perimeter of kelp, getting temperature, depth, condition of kelp and other observations Craig: the State is doing aerial surveys; kayak surveys are coordinated and designed to ground-truth what they see Kari: it's also a matter of getting community members involved and therefore more proactive

Kendra: Phil was concerned it wasn't integrated into larger picture, before effort from Dana Oster and DNR/Samish Now we have a better idea of where to look and a mechanism to get that data back to NWS

Beth: DNR has a new interactive map for floating kelp, looks like they have data from 2022 but not necessarily every site. They have comparison data from different years, can see extent over different years, etc. - interactive map

Sam: we just needed general head-nods of support

Kari: one last big piece of kelp news is next May 4-9, 2025 is the international kelp conference (<u>https://iss25.com/</u>) Sydney has a group called Cascadia Sydney doing something similar to what Linda and Sean and Mark just proposed

10:11 AM • Update on ERTV subcommittee work

Subcommittee has sent some questions to Brian Kirk at Ecology through Kendra to confirm some data in their analysis. We've discussed in the subcommittee and decided to keep it high level, just confirm data we need to move forward with the ERTV rather than get down into the weeds picking apart the report. Sent requests to Brian Kirk just for data concerning the risk reduction for Sidney and Roche Harbor. Once we get that, we'll move forward. Lovel: Brian assured me they'd be responsive

Cindy: I took that one-pager to Cantwell's office and representative Larsen. Cantwell's office is preoccupied with trying to get NOAA instituted as a statutory agency. Then they'll move on to the coast guard authorization. Lovel: My coworker Shannon Davis and can promote that one-pager as well, is that available for others to use? Kendra: yes, we also have a simpler 3-bullet one-pager

Cindy: I also have a tone-policed version

Craig: moving on to the next step, we still need Ecology to respond, but still need a peer review from a competent group. That may require some funding. That could come from the MRC or other outside organization Christina: why didn't Ecology do a peer review?

Craig: their response was that it was deemed inappropriate for peer review because was based on assumptions. Kailey: have we been in communication with Canada?

Cindy: yes the Trans Boundary Caucus, the ECB facilitate that, they're aware, Transport Canada is aware

Lovel: if SJC are serious about having one-to-one relations with Tribes, it would make sense to have a different type of membership on the MRC, not appropriate same type of representation with Nations

Kendra: we also have ties to the NWSC and some of their requirements, same with LIO, CAG, and SWAC.

Cindy: let's put together a memo for Amy, when she gets to the MRC let's discuss. Every committee has its own foundational document and code, Amy is working to establish a unifying code

Kari: with 14 diff tribes having UNA in the marine environment, that makes MRC different from other committees - Cindy points out some other ways a uniform ordinance wouldn't apply to all advisory committees

10:49 AM **Bellingham Bay MTCA clean-up and eelgrass harvest effort** Jason Stutes and Iain Wingard Iain and Jason introduce themselves. Colleagues from Landau associates are here as well - Jennifer Wynkoop, Gina Austin, and Carolyn Carlstrom.

The Cornwall Avenue Landfill and Salish Landing Park Project is large, an opportunity for eelgrass harvest and reuse. Beth Tate suggested this presentation to see if this group has ideas about how to reuse the eelgrass. This site is just south of Bellingham. Project proponents are the Port and City of Bellingham, we're helping to make it happen.

We'll talk about the eelgrass that's available and discuss some considerations for harvest and reuse. This material is from a couple of cleanup sites. Discuss project timeline and possible next steps for follow-up.

Project overview, 3 elements: Haley site cleanup, Cornwall Avenue cleanup, and Construction of Salish landing park.

All three elements constructed under one contract, project will impact existing eelgrass and mitigation is required. Focus here is opportunity to harvest and use the eelgrass prior to being impacted. Cornwall Ave site was historically used for lumber operation and solid waste disposal. There's debris and contaminants from past activities. This site is undergoing cleanup with oversite from Ecology. The Cornwall site is at the south end of the project area. The Haley site was used for lumber activities and wood treatment. Iain reviews some of the chemical compounds present

Salish landing park project will be constructed over top of the clean-up sites after they're capped. First phase will be implemented as part of the city's park master plan, public shoreline access, habitat improvement and amenities.

The project status and progress guided by the cleanup process, permits submitted and under review now. Ecology is reviewing design and we're talking to various entities about possible harvest and use of the eelgrass. Existing eelgrass in Cornwall project (shown in map), eelgrass used to plant the Cornwall site will come from the Haley site. Source of eelgrass transplants will be surrounding populations in Bellingham Bay. As part of the Salish park area, there's an additional 600 ft of e.g. available for use. Impacts mitigated under the combined cleanup/park project. Jason reviews the areas in acres that will be capped and the eelgrass shoots available (see in presentation). Eelgrass mitigation areas for eelgrass restoration are created in the design. Change in bathymetry from capping process, overlay will create a habitat bench suitable for eelgrass growth. Project sequencing and construction date will impact when eelgrass can be harvested. Vast majority of eelgrass at Haley will still be available, only small amount going to Cornwall. Because it's a remediation site divers will need to be OSHA HAZWOPER, process developed to decontaminate both divers and eelgrass. After that, eelgrass can be handled by volunteers. Harvesting can't impede construction timeline. We assume harvesters will take from remediation site and transport to reuse sites.

We did a literature review to examine the question of whether it was safe to replant this eelgrass given potential contamination. Jason reviews results of literature review, finding low concentrations of substances like metals and PCB's in Puget Sound. Conclusions were that uptake can be limited by low lipid concentration in eelgrass tissues. We've reached out to a list of entities that may benefit from reuse of eelgrass material, maybe in the San Juans.

There'll be approx. 700,000 shoots available. We want to hear concerns about risks, timeline and how to coordinate between large projects, how to codify, and how to come up with some possible next steps QUESTIONS

Kendra: you couldn't find enough sites in the Bellingham area to use all these shoots?

Jason: sites in Bellingham are small and can't reuse all the shoots. Some are contaminated and need remediation Gina: and timing needs to be correct. We're looking for shovel-ready projects that are already funded. Part of the cost of those project are often harvesting eelgrass material for transplant

Kendra: so not paying, you want projects already paying for restoration work that can use this material "free" Craig: how efficient is sediment removal to get the contaminants from the eelgrass? Are these rhizomes/shoots? Jason: these would be as intact as possible rhizomes with intact shoots, we'll do initial, secondary and tertiary pass Gina: the contaminant removal is very effective, should remove all the sediment

Dave: what's the success rate of transplants?

Jason: depends on site selection and how material is handled. It's disruptive, ensure not to overheat or desiccate, keep in flowing water can optimize success. We've had a success rate of up to 70% after 3 years, describes method Dave: best density for success?

Jason: can't plant at same density that it grows, plant in a unit of varying density in one bundle, Jason discusses the considerations for morphology, resource availability etc. for transplanting

Beth: I've been involved, connecting the cleanup team with CD and Jeff Gaeckle, who has a general permit to do eelgrass restoration in Puget Sound. The CD has been working with seeds recently but this is an unprecedented opportunity to have many shoots available, it's a reason to try transplanting. As for genetic variability; it seems like there's a line for the north sound and these shoots are likely to be successful here, not a totally foreign stock. I wanted to introduce this project to the MRC and the CD is here as well to make connections. This is a huge amount of eelgrass. Monitoring progress to this area could take up to a decade. If that restoration work is successful, we'll have a big lift in amount of eelgrass available in Puget sound. if we can't use it, 3.5 acres of eelgrass gets destroyed. One opportunity could be to harvest the seed heads and get those into restoration even if can't handle the shoots. One question is about the knowledge on the toxicity of the seeds, because they have a higher lipid content Jason: we don't know, nobody has looked at it, that would be an interesting research topic. Most of Puget Sound has some contaminant levels. Already a lot of information available at these sites

Kendra: are shoots largely healthy and don't have eelgrass wasting disease?

Jason: observational data shows morphology of grass differs with depth. At Haley, low evidence of disease Craig: about the metals, it would be important to do some analyses of the heavy metals in the eelgrass you're distributing. Since they seem to accumulate, could this get passed up the food web in eelgrass beds? Jason: speaking from conjecture, most seagrass not primarily consumed, enters through detrital pathway, particles that deposit feeders ingest. Need to go from primary consumers to secondary. No direct studies that I know of. Kendra: timing is the biggest issue. Spring would be the best time right before starts doing the season. Paul: We're targeting 6-10 restoration sites largely through seeding due to costs and efficiency but if these shoots are available ideally we could put them in embayments and study and monitor. We've been asking about toxicity etc. We've been working with Jeff Gaeckle and DNR. With a site like Westcott Bay, total remediation would be needed and it would likely be a wasted to transplant there. We want to avoid transplanting into areas where there's loss like the intertidal so that means the deep edge which means divers. We'd need more funding to be able to employ divers and boats, we'd like to be able to do this but conversation needs to continue. Jason: because these are Ecology remediation sites I'd approach them to look at seed funding to investigate that. Gina: It would be that expensive to do some analysis of the grass that's there and do some analysis of contaminants

Paul: We have a list of sites we're working on now and going through a review, not necessarily all shovel-ready Cindy: at the ECB meeting when they identified the sub-basins of interest, they didn't pick SJC and I raised questions about that, that resulted in an invitation to talk with DNR more about eelgrass projects here. I wonder if this offer is an opportunity for some kind of cooperative project, maybe even something experimental. ACTION: Iain will send this presentation to Sam to distribute. We'll discuss further with eelgrass subcommittee.

Need to review events from Tuesday of this week. Officials from the Coast Guard and Ecology spill program met with County Council following Chief Joseph boat sinking and discussion of that recovery. IOSA provided a good update of progress they're making. Not many people knew about this opportunity to meet. ERTV work was not included on a list of accomplishments, but Cindy did a good job of bringing it up. This is after Ecology's report with an incorrect analysis. Concerned about apathy around this issue. Need to make people aware of the true risk reduction values. Need more awareness about the program for derelict vessels and the ERTV conversation. Sam: thank you Marta, this was a missed opportunity, our department wasn't aware this was happening until after the fact. We do have the recording from Tuesday, it has been sent to the oil spill prevention subcommittee. This is an annual meeting organized by Brendan Cowan along with the Chair. I've tried to make a point of including Environmental Stewardship. They don't want it to be a big public meeting (although publicly accessible); it's meant to spark candid conversations about emergency response. Frances Robertson Surveys started, methodology working well. Focused on anchorages in known eelgrass habitat, at times of highest boat density. Further surveys planned (weather-dependent). Want a better understanding of boat numbers - Jeff and Frankie brief discussion of AIS data – some uses in the past and possible uses for these data e.g. a point when a survey showed 50 boats in Fisherman Bay but none were on AIS, boats don't always have it on One more comment about shore-based counts: several members participating in vessel counts. Frankie will send out aerial survey dates, getting counts on those dates is particularly important but getting data on other dates is great as well. Thanks everyone and thanks to Christina for connecting me with friends at Buck Bay Kailey: in the app, one field is 'tidal height' - is that meant to be real time, while there? Sometimes bad service Frankie: yes, at the time of the count. There are some nifty free tide apps as well Jeff: My coast has a tide graph too

Kari: let's coordinate timing with derelict vessel counts as well!

Update/Discussion on Fishing Vessel sinking near Henry 9:42 AM

Chief Joseph sank early May off Henry, 48' Fishing Vessel. Discussed and reported on in Council meeting Tuesday. Karin: I still feel there is a lack of transparency between emergency management and some of the responding agencies. Also, Fred Felleman, a Seattle Port Commissioner. He deals with a lot of ports and shipping issues, wrote a recent op ed in Seattle times. We hope in another oil spill we could move the needle a bit more https://www.seattletimes.com/opinion/the-tmx-project-this-ship-should-not-have-sailed/

Cindy: I learned on Tuesday that the Pilot's commission, appointed by Governor, oversees setting rules for mid-size cargo vessels. They voted to confine their rulemaking to a small area right around refineries, around Bellingham and Anacortes. If anyone has information on Pilots' commission or rulemaking process, I'd love more information

Lovel: There was legislation that established this process. Part of it required tug escorts for smaller boats that aren't required to have escorts by federal regs. Those expanded requirements have been in place in Rosario for a couple of years now. There was a process in place to look at expanding those rules to other parts of Washington. One possible outcome of rulemaking process could also be to rescind the rules put in place in Rosario two years ago. There will be reviews periodically (every 5 years). In an environmental process, they need to consider keeping the status quo but also look at rescinding requirements. One issue is that there are some impacts from additional tug escorts. When in service, their noise is absorbed as part of a 'package' with the vessel they're escorting. That's also being weighed in the environmental rule-making process. Haro and Boundary Passes would require a more complicated process due to transnational waters. It's a complicated process. Ecology and the board of pilot commissioners make these rules together. The same model used for ERTV analysis is being used for this rulemaking Dave: is noise from ships being adequately considered in these discussions? It wasn't a value in the Ecology model Lovel: yes, I believe they're aware of the research and science

Abigail: Quiet Sound program, <u>https://quietsound.org/program</u> developed in coordination with both US and Canadian authorities focused on underwater noise pollution, the only one I know of that gets into transboundary marine mammal issues. Lea Shields (NEP) works with a variety of authorities, including Canadian, on addressing transboundary non-point pollution but haven't extended to other pollution sources such as noise.

Marta: current tug escort requirements are shown to have notably reduced oil spill risk by 5-11%. Based on the Ecology ERTV report, the increased tug escort requirements have reduced oil spill risk in Rosario Strait by up to 11%.

Frankie: I believe that Quiet Sound is Puget Sound proper focused – one of the main actions is to implement a shipping slow-down through Puget Sound, mirrored off the Port of Vancouver's ECHO program.

Lovel: in the future if there's an opportunity to expand these rules into transboundary water ways, we'd want to engage the appropriate folks in Canada in that process. That may be a Puget Sound Parternship conversation. This also raises the importance of the need to be prepared for whale deterrence operations.

Kari: I also wasn't at the Council Meeting Tuesday and would have liked to be informed, I already poked Brendan. There was another boat that went down recently in the Cactus Islands and I wonder if that's been brought up. Cindy: Brendan just emailed that the Marina has engaged a contractor to remove El Capitan by 6/20.

- Frankie describes some whale deterrence tools and who can use them, very little work done on the efficacy of these tools at keeping killer whales away from a spill event. This area of research is desperately needed. Some information from the recent whale deterrence workshop; volunteers using these methods must be trained Marta: I believe USCG reported Tuesday that NOAA deterrence personnel were involved in Chief Joseph response. Kailey: as an MRC, could we all get IOSA training done together? We could work as a committee toward full training

Elaina: <u>https://www.iosaonline.org/training</u>, our schedule and how to reach out about training is on our webpage! Frankie: we were on standby, 1-2 teams were deployed on Sunday during the response. A helicopter was also deployed on Sunday but the SRKW were outside the potentially impacted area by the time it arrived on scene. Lovel: update on Transmountain pipeline expansion project, a second pipeline that triples production of dilbit oils. Significantly increases tanker traffic. The way the project was presented there were oil spill prevention measures in place, however prior to completion of the project new considerations for sizes of vessel that will be heading to Asia.

I'm in the process of drafting an email to the Coast Guard that I'll forward to this group. I wish I'd had the opportunity to be at Tuesday's presentation to address spill preparedness. It's really concerning. This is like oily sand that they mix with products to make it able to move through a pipeline, not a lot known about what this product will do if introduced into marine environment but likely to submerge and sink. Greene & Aschoff report, "Oil Spill Assessment Maps of the Central Salish Sea" looked at vessel route maps overlaid with bathymetry data to look at where oil may collect if there were a spill of that kind of product:

Need to look at circumstances under which project was approved Lovel: this is a Canadian project, they approved and issue the permits. They knew from studies that it would impact SRKW but given what they saw as economic benefits the project was approved. And there is some litigation ongoing, Lummi nation has a legal challenge in Canadian courts regarding their treaty interests.

Cindy: Senator Cantwell made it clear that Canada needs to be a good neighbor on this

Lovel: these tankers only have tug escorts when they're laden, when not still contain volume of propulsion fuel Dave: did you say that Ecology is responding to Federal Commerce

Cindy: no, State Commerce

- Some discussion about the current Neah Bay rescue tug and how it's funded. When it responds to a vessel in distress, that vessel pays expenses. But it still needs to be funded while it's on standby.

- More discussion about next steps, raising awareness, how to move the needle

Kari: good news, there were some updates on the El Capitan. CG, DNR, and Ecology were supportive of helping the West Sound Marina with some shared costs. The Marina has been arranging for boat to be moved by next week. Adam: we did 14 vessels through the turn-in event and 17 total as part of the program. Average cost per boat was a little over \$4K, about 4x less than if each vessel had been done on its own. We're talking with DNR about doing this again next year. This was their largest turn-in event ever, an efficient use of funds. Increased visibility to the public.

Kari: statistics on what was saved out of land fill: almost 50 tons, mostly recycled (scrap metal, composite plastic) Dana is here, thanks for support from NW Straits, looks promising for being able to do it again Dave: will there be a report available to document what you just talked about?

Kari: yes , we're working on that with all the partners, there will be a press release, we want to celebrate it. Dana: \$4,300/boat. we learned so much from that event, advertising for one in Skagit later this summer!

9:16 AM Presentation: Salish Sea Coastal Climate Resilience Consortium

Last year FHL began a strategic plan for the consortium. Aim to align with UW College of the Environment (COE) on confronting challenges. Seek to build research and education partnerships, expand FHL outreach. New initiatives at FHL, focusing on local and regional scale:

-proposing development of a Salish Sea Coastal Ecosystem Resilience Consortium. Worked with WWU (the project lead) and a number of other partners – the proposal didn't get funded but still working on the idea.

-Working on a COE task force to develop a new professional master's program in environmental sustainability. -Last September/October 2023 held a Climate Action Speaker series on San Juan Island with the Madrona Institute Local Sustainability Opportunities for FHL campus and beyond include,

- Electrify our vehicle and vessel fleet. Boats are a significant source of carbon inputs
- Replacing the RV Kittiwake with a lower carbon alternative, some discussion of good alternative to diesel
- Eliminate wood burning on campus. This is a significant carbon input to the atmosphere we should reduce
- Improve our building energy efficiency (better insulation, heat pumps, solar, etc.)
- Getting involved in OPALCO's tidal power generation project
- Becoming a community solar provider would while reducing FHL's fire risk (more on this shortly)

FHL has Biological Preserves both on San Juan and Shaw islands, nearly a third of Shaw Island is biological preserve of which UW is meant to be the steward. But no funding for the stewardship/maintenance. (Chuck shows maps). FHL campus is on the edge of 476 acre preserve. Idea of a fire break between campus buildings and the rest of the forest where solar panels could go, generate not just power for the labs but enough to export to community There's also Argyle lagoon, False Bay, and Ellis and Cedar Rock preserves on Shaw totaling over 2.5 square miles. The Coastal Ecosystem Resilience Consortium will have a coastal climate ready workforce Training at FHL; seeking funding to support a 10-week coastal climate resilience program each summer for post-baccalaureate and gradu-

ate students. Two-week professional training followed by 8-week apprenticeship for 15 students to participate, introduced to field methods in coastal and resource management. Instructors from all over the world, received 49 applicants. 15 students accepted, another 32 will participate remotely (as well as others)

The El Capitan was picked up and removed and crushed. That was major for the County. I have some ideas for the Fair for the Derelict Vessel group. Hopefully not too many vessels to retrieve this season, just a lot of outreach. Q: what were total costs for the El Capitan?

Kari: the marina bore most of the costs together with the vessels' insurance, and then DNR and Coast Guard money for dismantling. Total estimates were around \$1.5 million. Interventions prior to sinking were up to \$20K Marta: that response for one day to remove the water it was taking on at that time and all the hazardous materials was \$80K, and the estimate we got was over \$400k. DNR couldn't fund that because it's a private marina, not State-owned aquatic lands. We don't want other private marinas to think they can tap into those funds Kari: they used the voluntary vessel turn-in for the State (which the State was reluctant to use) Question: what's the incentive to get to a boat like this before it sinks in future?

Kari: normally there's a clear path of ownership and the owner is responsible. If they don't have the funds, they can take advantage of the voluntary turn-in program, but in this case ownership was unclear. One thing we want to work on this fall is round-tabling with marinas; we'll use this as a case study to not get stuck in this kind of situation Sam: we've touched on the retreat coming up in November and how each MRC will have a station to present their work, we've talked about having DV work be our station. Kari will you be available and able to assist with that? Kari: Yes, and I've been in discussion with other MRC's about DV programs and how they can set them up

Flying again July 20, August 3, and Labor Day weekend. Frankie is working to amend contract to get in a seventh survey in September

Karin: when you reported about that to NWSC, Jefferson was very interested in how it was funded. Question: any special equipment requirements?

Frankie: visual observations, inclinometers. Datalogger with software recording cloud cover, glare, sea state, etc. No specialized aircraft equipment. For insurance purposes hire San Juan airlines, generally not with volunteers. -more discussion of timing of surveys

Sam: the other program we're using one-time NOAA funding for is the benthic habitat mapping with Gary Greene

• Karin: this brings up the issue of pumpout stations that came up during Covid. If you're seeing twice as many boats on one day in the summer, likely means those resources are stretched thin. Should we investigate this more? Christina: now there are mobile pumpout services on Sucia

Frankie: State Parks boating program has brought up their pumpout boats, they have funding for us but we don't have the infrastructure to manage those programs. Mobile pumpouts need to go back to the mainland, they can't put that waste into our system here. If there's no mobile pumpout, a boat will need to go to where the service is Beth: We had a presentation about this a year ago, funding from Parks could be used for salaries/staffing Frankie: private marinas get support from the State, Roche Harbor has both mobile and shore-based stations. They got overloaded in 2020, Other marinas less so because they only offered pumpout to those moored there. Most private marinas should be offering pumpout systems, that'll be part of our marina roundtable this fall. There are a number of docks whose pumpout systems have failed on Lopez and there are efforts to get the Port to fix them.

• Katie: we just wrapped up spring quarter – please fill in volunteer hours on spreadsheet, send in hours to Katie

• Cindy: the supreme court decision regarding Chevron will affect the EPA

Dave: the funding of the ERTV is basically a tax on vessels. That may be affected by this court's decision as well. Cindy: PSP groups haven't met since that ruling. EPA won't be reporting on that. Need to find a way for legal analysis

Karin: and other agencies like Public Health etc. will be looking at their jurisdictions. It's a bummer Cindy: we'll have our work cut out for us with advocacy for legislation

Traffic the vessel will be serving is bound to Vancouver, and problem with Neah Bay tug is the funding mechanism. The Transmountain pipeline just opened its floodgates and came with a great deal of funding from Canadian government. The question is how to make it happen politically. There is a Canadian group in maritime research about to produce a report similar to work Lovel has been doing; it'll be an official document. It would be great if we had a forum to review this new report and threats to our waters to which we'd invite our representatives. Make it clear what needs to happen to strategically protect our waters, show the risk, and make sure our elected officials know who to talk to. This would be an expedient way to get the tug near the San Juans, but this timing window is short. I'd like the opportunity to further discuss this with the subcommittee Lovel: thanks for coming and speaking with the MRC. Just to assure you, we're not at cross purposes. We recognize the appropriateness of Canada funding this. You have a great idea with this upcoming report from Clear Seas, I connected them with the Salish sea institute so they can collaborate on transboundary projects. And if appropriate, can we invite non-MRC members with expertise to participate in subcommittees?

Restoration and shore-friendly programs. Four core programs including nearshore restorations and shore-friendly landowner. Jason will discuss derelict gear and citizen science monitoring, Don will discuss the internship program. 2022 Milestone: 1 mile of shoreline restored, working on small stretches at a time, total 12-13 projects, plans projected into 2028. Working with landowners on Weeks point, slow pace dealing with archeological issues. Stewardship – ensure we have ongoing funding once construction is done. Vegetation or adaptive management. Fundraising currently focused on this effort, e.g., ensuring there's staff to water riparian vegetation. Shore friendly program – primary goal to reduce effects of armoring while protecting habitat. Friends of San Juans is the lead for shore-friendly projects here, we contract through them for many things. Goal to work with communities and private owners on projects they may find overwhelming on their own. Education to know bulkheads aren't best solution to deal with shoreline erosion. Friends have conducted at least 90 site visits. We're working on a development curriculum for land-managers. Education about what's required on a shoreline. Lisa shows poster available to intercept planning departments before they put in a bulkhead. Starts with outreach - beach walks, site visits, helping through engineering/design/permitting - all of that can be free for landowners. Then there can be grants, cost-sharing, etc. We require consultants who work with landowners to focus on setbacks and dealing with issues of erosions. Every report needs to discuss whether homes need to be moved back. We've been working on a series of short videos, we have six out now. Focus on native plants, trees & views

• Derelict Gear and Monitoring –

Jason Morgan

In 2014, we started restoration monitoring – physical and biological surveys. We analyze individual sites (28 restoration sites throughout Puget Sound). A lot of work in Skagit, Jefferson, and Whatcom counties. The derelict gear program aims to retrieve objects that are harming animals and degrading habitat, like fishing nets degrading rockfish habitat. A lot of funding from NOAA and fisheries. Jason shows map of nets removed. A lot of them in SJ's. Over 5000 nets removed, over 11 million lives saved each year in terms of entangled marine animals. Many removed were old 'legacy' nets. Now we have a hotline, derelictgear.org or 360-733-1725, anyone can report. Divers on standby to do the work. In future we want to have a reporting app.

Derelict crab pots, we're losing 11K each year. Over 85% recreational, but some are commercial. The main impact is on the Dungeness crab population. Map showing where derelict pots are removed, not feasible to get them all, try to target areas of high-density. A big part of the issue is education – pots without weights etc. A lot of MRC members have been helping distribute information. Sometimes distributed with the crab pots when they're sold. Jason shows stats for nets and crab pots removed and acres restored in SJC – represents 40% of total work done

Don Hunger: 2-3 years ago, we got an AmeriCorps grant for a conservation corps in WA state. We launched a program during school year for 10 individuals –provided mentors for each student, monthly field trips, and training seminars with scientists/experts. Allow students to apply academic studies in real world projects, teamwork and collaboration. We've had three interns with Island, Skagit and Whatcom MRC's. We found that we can write grants for college students in conservation services, many students looking for internships (received a lot of applicants) and rewarding for MRC members to work with interns. We continue to write grants to fund the school-year based conservation corps. There would be an opportunity to have one or more members come out this fall/winter/spring as part of a workshop or working on a specific project. We want to involve MRC's more. We may look for SJC MRC to pay for transportation or some costs. Could be a pipeline for future MRC interns for SJC.

On grant-writing and collaboration with MRC's: I've been executive director for over 5 years. In pursuit of money for projects, learned we need to be specific – a project needs a location, timeline, and benefit. No open-funding grants. Donors are looking to invest in a County for certain types of work that'll benefit communities. Not just 'various projects'. I created a simple form to help with this: "what are goals/dates of projects? What's needed – partner, grant, in-kind resources?" the form can be emailed to Don. We're always looking for sources of corporation or foundation funds that can support restoration work. Typically, a grant proposal takes 6-12 months. These are things we need to think about for the coming year or for projects on which there will be a gap in funding

Olivia: do you have a link where folks could submit ideas for proposals for projects?

ACTION ITEM: yes, Don will email it to Sam to distribute

Olivia: Do you have some of those materials about the derelict gear and catch more crab campaign? I can help take those to local business on SJI. Are derelict gear observations on the surface or underwater?

Jason: prior to crabbing season we reach out to all MRC's, we have plenty of those materials and thanks, here's my contact, <u>morgan@nwstraitsfoundation.org</u>. Legacy nets are identified using side-scan sonar.

Olivia: if there could be an opportunity for recreational divers to keep an eye out and have the information about reporting, maybe WA Reefcheck or local dive shops could share that with their network

Jason: some of our reports come from divers, e.g. one net found off Eagle Point by Joe Gaydos Cindy: Ferries are having increasing difficulty navigating around crab pots. How much of that is derelict gear? Jason: establishing lanes where folks can't set gear is difficult, it's more about education as to how to set gear Kendra: I wonder if we could produce a map to show where the lanes are and make a request they avoid those areas for ferry navigation. Not prohibiting but communicating, just a lot of new boaters.

Cindy: Some background on what's gone on – a lot of focus on having Canada pay for this/having it stationed in Canada. Cantwell has been waiting for the Ecology report to come out. After that, data didn't make it apparent enough how important it was. I love the idea of a conference

Fred: it doesn't need to be a bilateral convention. Report will likely be done late august/September so I was thinking October would be an appropriate time frame. Clear Seas is amenable to the idea, not just another technical conference but different inviting politicos. Many thanks to Marta and Lovel

Marta: we really need to convene and get more partners, specifically the Tribes.

Fred: I've given up on Ecology, they know they're out of their jurisdiction and they put out a report that underrepresented the data and minimized the need. Their relationship with the Coast Guard is important to them. But now Ecology is not the audience, it wouldn't be the first time we had to get things done without Ecology. Marta: They still need to be held accountable about the errors they made and come forward with correct values Fred: but target audience for me is the Legislature, we want to make sure they get the right information and the substantiative report once corrections are made

Lovel: meanwhile Trans Mountain pipeline spur is full . Between May 26-July 26 there were millions of barrels of Canadian crude oil delivered to our northern refineries -- a significant amount of Canadian crude oil being transported over water and delivered to refineries here

Dave: what's the route that Canadian tar sands come down and is there a tug escort for those vessels? Lovel: Vessels go from Victoria to Port Angeles, then proceed to Vendovi anchorage or one of the refineries. Condition of Trans Mountain pipeline expansion project permit is to have two tug escorts, but if they stop at Victoria before coming across, two tugs aren't required for tankers in the US, it was a special permit requirement for vessels from the Transmountain project.

Unclear if they have tug escorts when crossing Straits of Juan de Fuca

• Final CAG Scoring and Ranking of 2024 Salmon Recovery/Riparian Funding proposals (Sam shares screen) This is the meeting to finalize our scores and rankings, final rankings due mid-August. This has been a big, complicated grant rounded, over \$2million in funding including riparian funding. Sam provides a brief overview of the process and timing starting in March with letters of interest to the TAG, four SRFB and three Riparian proposals. Stie visits and preliminary evaluations in May, SRFB review panel completed evaluation in May and provided status designations for each project which must be cleared by that panel. At that time, one project was cleared – the Land Bank East Sound acquisition, and one project of concern (the Friends of San Juans' Davis Bay), the others were designated 'need more info' which usually means project is in good shape. Final proposals were submitted by late June and all seven projects were cleared by mid-July. Sam reviews funding what's available vs. what's requested. Total WRIA current WRIA 2 2024 Salmon recovery allocation estimates (including PSAR and return funds swapped last year because unused by Agate Beach). And WRIA 2 Salmon recovery proposal budget, we have a little more requested than we have available. For riparian funding, Sam shares total funding budget plus proposed budgets – also a little more requested than what's available

Rankings: Sam explains basis of scores and percentage of each component (benefit to salmon, fit to plan, and socioeconomic). CAG scores on socioeconomic benefit to Islands community

- Sam shows ranking:
- 1. Jackson Beach
- 2. Davis Bay & Richardson Marsh
- 3. Land Bank acquisition in Eastsound
- 4. eDNA fish assessment

TAG recommends funding for all four projects. The difference between what we have available vs. what's requested is almost exactly price tag of eDNA project but TAG wants it to be funded. TAG proposes pulling form request for third project and reducing by amount needed to fund the eDNA fish assessment, approx. \$84K

Sam spoke with Land Bank to see if reducing amount would torpedo that project, they said no.

Cindy: the eDNA assessment is important to determine which streams have salmonids.

Lovel: do we need to make a motion to support TAG's recommendation or just vote on the rankings? Sam: we need to do both, can lump together in one motion

Olivia: For the eDNA assessment, my team has eDNA data from five sites for past several years, glad to share those Tyler: Thanks, Olivia - I'll follow up with you

MOTION: Adam moves approve the ranking with the recommended reduction of \$84 K from the Eastsound acquisition applied to the eDNA project. Dave seconds the motion.

Sam: for Riparian, if we fund the top two projects, leaves \$47K for the third, Lower Cascade Creek Riparian Restoration project. TAG was in favor of boosting budgets for the first two projects. Since then, clarified with Friends of San Juans as to whether partial funding would be helpful - they'd revise the scope. What does CAG think - partially fund third project or reallocate to the top two?

Dave: I like the idea of getting partial funding, if Tina says it can get the ball rolling I'm for that

Kailey: I think we should also give that remaining money to the Cascade Creek project, the Cascade falls is already protected, why not keep the protection going further downstream?

Kat: Or they can add match if they get another funding source

Kat: my only concern is that we'd need a scope of work reduction, I'd need to talk to the panel. And there are other sources for riparian funding, perhaps they could use the \$47K and find another source to match – then they'd have the full scope with our funding making up a smaller portion. Maybe they could partner with a CD for funds Adam: if there's a plan in place for how they're going to spend that extra money I'm in favor

Sam: Ok then I'll circle back with Tina and Kat and the panel and ensure there's a plan toward implementation Kendra: consideration for sea level rise given its location, there will be inland migration of the sea in that location MOTION: Adam moves to fund all three projects proposed for riparian funding, allocating \$47K to Cascade Creek on condition of a reasonable plan being put together. Dave seconds. All in favor Sam: thanks everyone. This round represents a significant investment. great to take advantage of Riparian funding.

9:22 AM **Presentation:** Update on SJI Conservation District Eelgrass Restoration Project *Mitch McCloskey* Mitch presenting in place of Paul Andersson. Mitch introduces the concept, collecting seeds avoids destruction of the donor meadow as well as other benefits like genetic diversity. Steps for restoration success: adaptive management, regularly assessing implemented practices – evaluate and adapt. Address problems systematically.

- 1. Project Site Identification, potential planting sites and harvest sites
- 2. Project Site Assessment, CD doesn't have resources for scientific diving. But a new HSIL just approved for eelgrass meadow health assessments. Involves sensors monitoring conditions in eelgrass meadows

3. Final step is project site evaluation, workbook for site evaluation, collect data systematically This year had the opportunity to use student volunteers from the Marine Subtidal Ecology (MSE) course at FHL, that and field collection at Padilla Bay meant a big bump in seed volume collected relative to last four years 2020-2023.

We also want to know the impact on the meadows we're collecting from. During the MSE we assessed subtidal harvest techniques for collection. We've also been expanding relationship with Padilla Bay, ran a pilot study to build "harvest best practices" – plan to continue for the next three years with Sylvia Yang. Padilla Bay is the largest eelgrass meadow in the lower 48 states, and with a similar genetic signature to eelgrass in the islands. Eelgrass Cultivation System (funded in part by SRFB grant) at FHL to maintain flowering eelgrass heads.

Viable Seed inventory – testing seeds, counting seeds by weight, etc. Planting planned next spring, injecting seeds SRFB objectives – to expand collection sites (Padilla Bay, plus sites in SJI's – Jackson Beach and Shaw County Park) -expanded eelgrass cultivation system, as well as analysis and techniques

-community involvement with future scientists, hope to continue involving students from FHL and maybe also YCC -and finally, adaptive management to maintain seed bank. Develop site selection workbook etc.

QUESTIONS

Kendra: how are you assessing study locations relative to physical disturbance?

Mitch: the goal is to look at all environmental variables, long term-monitoring data from DNR and Friends of SJs. Kendra: needs to be conservation measure i.e. publicly owned or blocked so not destroyed by anchoring. Should look at boating traffic for best success. And work with partners like DNR to cordon off areas as no-anchor zones Frankie: We are also partners on that HSIL to look at physical disturbance and impacts from crab pots and vessels. You should mention our vessel impact work and involvement in those efforts, boater education and outreach for eelgrass. Were there no restoration/monitoring efforts as part of SRFB?

Mitch: we didn't get full approval for planting until just a few weeks ago due to cultural resource issues. Frankie: at least one of those sites has been slated for restoration efforts so we should talk about timing Mitch: part of the workbook effort is to facilitate conversations; we don't need to seed at all of these sites this year.

Kendra: we do have anchor out buoys in some locations and DNR leases, if those sites align you may want to look at them first because they have a protection standard. As does the Land Bank with a number of shoreline properties.

Mitch: the workbook can facilitate input from experts, rank elements in importance – is it more important that there's an anchor-out area or that there's an historic meadow?

Adam: how are you going to survey for those expert opinions?

Mitch: we've been targeting specific individuals, doing literature review, build relationships with scientists Tina: kudos to everyone for all the momentum around this habitat – Sandy, Olivia, Drew, etc. We've been remapping eelgrass county-wide. Olivia has a new paper out on eelgrass disease in the SJI's.

ACTION: can we get a link out to Olivia's paper?

It's exciting to have all these data and the MRC in role as CAG is helping to facilitate this work. But we have an eelgrass crisis in the islands. Now from county-wide data we're understanding that deeper beds are more resilient and we're losing the upper beds. You said that's informing the seed collection but is it also informing the planting for best chances of success? I think depth will be a critical factor

Mitch: we've been largely working at the seed collection part of the process but plan to work on next steps Jeff and Wendel coming to the islands soon. Plan to get everyone in the room to talk

Tina: we also plan to have a meeting

Olivia: can you remind me when Jackson Beach restoration will occur?

Frankie: we're putting in for remaining permits now, likely work for next September 2025.

Kendra: there's still some discussion with Public Works about the possibility of a barge landing there. We want to make sure that doesn't happen in an eelgrass area but that is a major barge location for the County Olivia: the team hopes to put out a sensor in the eelgrass meadow there in the next month or so ACTION: Olivia, Mitch, and Kendra will connect about this offline

• OPALCO's planned tidal project off the east side of Blakely Island Karin Roemers-Kleven Karin: OPALCO has announced they're planning a wave energy project, a floating device with turbines. Must be somewhere with a lot of current. They identified several areas, like Cattle Pass, but settled on Blakely. It would be great to have someone from OPALCO talk about this to us

Frankie: we have several representatives from Tribes here (Gregg, Heather, Patti), a lot of interest in this. Tidal can be extremely expensive, early days in terms of engineering. Some objections from Tribes over treaty access Heather: I'm the environmental policy manager for Swinomish, my colleague Sydney Cook is here. We recently had a call with OPALCO and their consultants. They've been communicative but light on details. As Frankie mentioned, the Tribes have concerns about impacts to treaty fishing, and on mammals and on resources. The preliminary designs for tidal turbine and how they intend to anchor it to the sea floor has a lot of potential for entanglement with marine mammals and fishing gear, could obstruct access. We plan a follow up call in October, we expect additional materials, when they apply for permits and EIS there'll be additional opportunities to engage Lovel: Friends of SJ's has also had preliminary talks with OPALCO. MRC could encourage Council to ask OPALCO to have a completely transparent process. We haven't received all available information. There may be factors they didn't consider in choosing this site in terms of marine resource issues that we could inform them about. Adam: for transparency, are you suggesting we send a letter as an MRC?

Lovel: I think we can make the recommendation to the County Council and it's up to them how to encourage OPALCO ways to improve the process. I appreciate the County's efforts

Sandy: could you circulate the WSU study on salmon? It would be good to see the structure they used ACTION: Lovel will share the link

Patti: It's good practice to contact every single Tribe that has treaty rights there. Thank you, Swinomish, for the work you're doing. Before they get too far down the road better to get into consultation. We need to protect the salmon, the eelgrass, everything on the bottom of the Salish Sea. Tulalip receives billions of consultation letters and by the time we get to all of them it may be too late. We're just beginning eelgrass restoration efforts on our reservation; we want to be involved in this. In general, why not invite all the Tribes to see what this is about. Heather: thank you, Patti. When OPALCO reached out to Swinomish I encouraged them to reach out to other Tribes. My first recommendation was to reach out to NW Indian Fish commission to get contacts for other Tribes. Sounds like we need to push them a little harder on that, an all-tribal presentation is a great idea – I wonder if the MRC could work with NWIFC on that. Tribal consultation needs to be early, often, and continuous Olivia: can anyone bring me up to speed on this initiative? OPALCO is trying to move ahead – is it happening? Frankie: there have been two public meetings so far. One six months ago and one last week. Not much movement. They've received funding to explore and do studies with that site in mind. that may be as far as they get Tina: they're getting grant funding for various stages. They got an early scoping grant that helped them select the site and the technology. Now a new grant for the next phase. But the economics don't pencil out exactly for how many turbines they would need. They are planning to apply next April for a permit to put it in. It'll be a long process, but I agree that we can encourage more transparency. They're pursuing it but don't have a permit yet Cindy: I'm very glad to see Tribal partners at the table. When OPALCO first called about this project I said they needed to hire a Tribal consultant. I'm disappointed there hasn't been more communication. Heather: Swinomish staff reviewed a Corps of Engineers permit request to deploy a buoy offshore in this location to collect data so they continue to investigate this area.

For the NW Straits, I visited five sites among Lopez and Orcas where there are eelgrass buoys. So far, I've done 65 site visits. I also compiled all SJC data into a separate spreadsheet to make it easier to see. One interesting thing I saw looking at the different vessels is that locals used mooring buoys more.

Frankie: when recording boats, did you also record the ones on mooring buoys?

Roan: I asked NW Straits and they asked me to count the ones that were on anchor; I also counted the ones that were on mooring buoys but included those in the notes. They can be edited to add those in

Olivia: how often did you see boats anchored and mooring balls empty?

Roan Ontjes-Degroot

Roan: where there were only a few buoys they are generally all in use. For places with more buoys not always Frankie: we've heard from boaters that they're concerned about the state of mooring buoys at Watmough Kendra: we've had no dedicated funding or strategy for this

Frankie: there's been an increase over the season, August 3 there were 200 boats at Sucia, July 20 there were too many to count. During good weather, peak summer/good weather

Olivia: are there any other counties that limit the number of boats that can anchor out?

Frankie: Jefferson has an anchor out zone they deploy each season, they do regular counts. We put one in at Odlin which was a requirement of the aquatic lease because there's a dock there.

Tina: we had a number of anchor-out buoys for herring spawning sites, never made it through permitting with that. It's too much stuff in the water. Pivoting to mark in navigational. And issues of whether they're public or private

Olivia: as you think about drone imagery, our team has done some mapping of our 5 sites since 2017. Primarily focused on intertidal but also some shallow subtidal. And some considerations for mapping from parks ACTION: Frankie and Olivia should discuss this more

9:45 AM • Update on ERTV Subcommittee meeting with Ecology *Subcommittee members* Sam: several subcommittee members are here (Lovel, Marta, Dave, Craig). We had a call with Ecology a few weeks ago, somewhat disappointing in terms of them responding to our requests

Lovel: Marta has created a spreadsheet in which Ecology can fill in blanks to correct data. We still find it important to pursue a review of the model for the accuracy of the effectiveness of an ERTV but also concerned about this model being used for future projects and studies despite its inaccuracy

Marta: Ecology acknowledged they had found errors that affected risk reduction results. It included 24 numbers. The changes may be minor, but measurably affect results They have said they won't pursue peer review. This model could be used for future decisions using State funds and affecting policy/regulations regarding shipping. We think it's necessary and valuable to proceed with peer review. We'd like to hear comments from MRC about justifying that

Craig: I support the peer review but must be realistic about what it involves. normally review involves subsequent revisions with Ecology is unwilling to make. The alternative to revising following review is to reject the study.

Lovel: One important detail is to approach the Governor's office with our request – Sam and I met with staff there

MOTION: Lovel moves that MRC support ERTV subcommittee in pursuing corrected values and a peer review from Ecology. Craig seconds

Adam: how do you foresee us showing support?

Lovel: signify support to proceed to next steps. Kendra is in touch with staff at Ecology and appropriate for that to continue. But a formal request would need to be a recommendation to Council

Cindy: I'd like to hear more about Sam and Lovel going to the Governor's office. Sam should come to County council meeting and bring this letter. Good to get Council's buy-in if you're in communication with Governor's office

-Lovel provides more detail about meeting with Governor's staff, discussed next steps, didn't request peer review

Cindy: when they went through methodology, made it clear they thought error was insignificant. I believe we need to push for peer review of that model. One idea is to do another study

Marta: need to go back with the spreadsheet and ask them to provide the 24 numbers we want. Some of these results just don't match with our response study. In the correction statement, it's referred to as a 'small change across the study area' but we want the new numbers for zones that are higher than what they've reported.

MOTION *restated*: Lovel moves to support the ERTV subcommittee's request that Ecology provide corrected values for tables in the ERTV Effectiveness Analysis appendices and identify next steps to secure a peer review of Ecology's model. Craig seconds (again). All in favor, none opposed. The Motion passes.

10:17 AM Presentation: Sea Level Rise in San Juan County

Our study on sea level rise vulnerability risk assessment has come out. Final report approved by county council 9/17. Full report at https://engage.sanjuancountywa.gov/

The purpose of this exercise was to identify coastal areas in the county vulnerable to climate-driven sea-level rise to help plan for the future. County has the FEMA maps of 100-year flood plains but now have various GIS layers for different scenarios. Looked at 12 specific sites known for sea level erosion issues and four Scenarios (2' and 5' sea level rise in the 1-year and 100-year flood plains, respectively). Tyler shows the 12 sites. Just False Bay on SJI, two sites on Shaw, several each on Orcas and Lopez. 100-year flood plain parameters likely to start happening almost annually. Tyler shows list of roads and community assets (e.g. OI airport and Orcas and Shaw ferry terminals) at risk of erosion and other issues like inundation. Table 6.1 details building and other infrastructure in the county that would be affected. Story map, easier to consume than entire technical report.

Strategic funding within a focus area including priorities for salmon recovery,water quality, climate adaptation etc. Encourage collaborative riparian applications across watersheds.Investment Plans and Priorities – invest in riparian programs at a watershed scale. Six focus areas:

- 1. Reach-scale approach to planning and outreach, strategic approach. Regional coordination and planning, landowner engagement and recruitment activities, etc. We want to help pay for those efforts
- 2. Native plant materials: plant propagation, procurement, holding facilities, etc. Ensure no roadblocks to getting plants when needed. Getting plants in the ground design, procurement, and establishing plants.
- 3. Maintenance, Monitoring, and adaptive management. Focus on providing long-term riparian project support
- 4. Landowner incentives still working on this. Focus on BMP's that help address needs of landowner while we're planting i.e. fencing, watering. We're interested in novel approaches from applicants
- 5. Permanent Protection of Riparian Habitat acquisitions, easements, etc. to preserve lands intact when they're under threat of development or being restored
- 6. Future eligible proposal activities innovative landowner incentives, maintenance support stipends, and other activities to consider for future, we're still figuring out

Projected funding availability and key dates – approx. \$9milion, solicitations potential in summer 2025. Contract start in March, work next summer. Minimum awards of \$500,000 and max award of \$2,750,000, no match required because that's already coming from federal funds. Kendra: in Snohomish training, I wish I didn't see those plastic tubes! They add no benefit, costly and wash down stream and cause problems, encourage not using them. And we may not be eligible because it's expensive in the islands and limited salmon use of system but if truly climate focused there would be some water quality benefits. Craig: landowner incentive payments, especially for ecosystem services, are those just for the duration or ongoing? Because if there are costs incurred for loss of land it'll be ongoing

Colin: we're working on that, emerging challenge

-More discussion of how this will look on an applicant-by-applicant basis, adaptive with respect to climate resilience

Dave: what other things could we do to enhance salmon spawning grounds?

9:08 AM **Presentations/Panel on Kelp Aquaculture** *Emily Buckner and Jodie Toft, Amy Carey* Emily: We're here from Puget Sound Restoration Fund (PSRF) to speak about kelp cultivation. Our mission is to design, test and spearhead in-water actions to protect species in PS waters. We have many collaborators and partners. I'm the crab and seaweed programs manager. We help scientists, tribes, and fishermen work together. I'll talk about previous work with NOAA to develop best farming practice recommendations, and ways to promote algae growth.

Jodie: I've been at PSRF for six years as the deputy director and then transitioned to executive director role. Here today to talk about kelp restoration and action. We hope we can be a good set of resources to talk about kelp farming.

Emily: I'll talk about ecological considerations for commercial kelp farming. We published a paper on this topic in August 2024, in Marine Fisheries Review, written with NOAA. Big regional interest in kelp farming, a new industry we want to get right, put in regulations to set up for success and not make mistakes in marine environment. First, identified potential ecological impacts, looked broadly in literature and talked to experts around the world about what could go wrong. Second step was to apply those broad issues to our local context and native species. Third step was to move into research and adaptive framework for the industry, pilot projects to test questions. Step four –develop best farming practices, continue to monitor, assess and back to step 1 – look for potential impacts. Here we're really talking about the first two steps. Potential impacts from review of global literature:

<u>Habitat Impacts</u>, Crop could provide habitat/refugia for native species. Then harvested and refugia are removed. Forage fish spawn on marine vegetation; if regionally important fish like herring spawn on kelp that's harvested then spawn could be lost. Farm infrastructure itself (buoys, lines, etc.) could also cause disruption or entanglement hazard.

<u>Water quality and nutrient subsidies</u>, Crop extracts nutrients, chemical s and metals from water column and absorbs carbon/stabilizes pH. But if water is nutrient-poor, crop could compete with other organisms. Crop can provide nutrient subsides in the form of detritus, particulates, etc. but could also overload the system <u>Hydrology Impacts</u>, Farm infrastructure/crop dampens wave energy, potential for shoreline protection <u>Benthic Impacts</u>, Farm anchors/moorings create habitat-forming reefs, but these can also disturb the benthic vegetation and seafloor. Cultivated kelp could overshade benthic vegetation, compete for light <u>Genetic Disease Impacts</u>, Crop could populate environment with reproductive material, influencing wild genetic diversity, crop could spread disease. But can also assist in restoration efforts, reforestation of wild beds. Our local context led us to zero in on a couple areas of emphasis kelp farm regulators will need to pay attention to: First is marine spatial conflicts. If kelp farming takes place in public waters, shipping and other vessel movement, infringement on tribal treaty fishing rights. As well as infrastructure, chains/moorings/etc.

And the issue of genetic diversity. Also concern around forage fish like herring spawning and not removing crop with spawn. Emphasize risks to marine mammals considering their importance in our region. Most of these concerns can be handled with good siting and research. Need to test best farming practices to see what works. Best practices may alleviate many concerns. E.g. with treaty right fishing, siting farm properly and include Tribes in the process from the start. With marine vegetation, it can be a matter of type of anchors used and siting away from eelgrass beds. As for genetic material drift, we can source genetically local strains. Siting to stay away from spawning areas and rules about not harvesting crop with forage fish spawn on it. For marine mammals, it's about smart siting and avoiding high traffic areas, like the west side of SJI. There are no known examples of mammals locally entangling in kelp farms.

Jodie: shift focus away from commercial side and into restoration aquaculture. This part of PSRF exists because for a while we were the only ones doing kelp aquaculture, and we were doing it to test the availability of sugar kelp to affect local water conditions and pH. We've been doing this for a while – figuring how to put seaweed back in the water and how to test what it's doing, we have experience permitting and growing the seaweed.

How do we reintroduce bull kelp in places where it has declined? Need to reflect on what we know about bull kelp. They're the forest builder kelp in the inland Salish sea. It's not doing great anywhere; we don't know how it's doing everywhere. Jodie shows data from Floating kelp forest indicator for WA State with assessment of where there's kelp. Colors on map show areas of decline, concern, stability, and patches of no data. South there's a lot of decline, some insufficient data in Admiralty Inlet and some areas of concern in North Sound and SJ waters. There's been 305 acre loss from 2006-2016, a 36% loss in one decade. Some beds matter a lot to certain groups. Our goal is to introduce "plants" (actually protists) and have them generate the next generation canopy the next year; for them to grow up and create seed bank on the sea floor that can restart the cycle. We hope those methods can be feasible and scalable.

Jodie tells about one bed in central Sound, "Jefferson Head". Chart from 1800's shows kelp as a navigational hazard. Local Tribe wanted kelp bed to return but needed keep restoration work shoal-ward of existing geoduc tracts.

Early trials: tried making "green gravel" (i.e. seeding gravel and moving it into the marine environment,). Then tried sporophyte and psori transfers – this is feasible but not scalable. Made a notched-pyramid, unspooled a seeded twine. It worked – kelp grew up with reproductive patches; produced mature sporophytes (adult kelp) but did not reach surface and did not produce next-generation forest. But a promising technique. Adapted that technique to use thick anchored line and shuttle seeded twine along it. This strategy approximates farming. Seeds were collected from kelp around Salish Sea. In Central Sound we try to take samples from nearest neighbors. But we're glad to have a seed bank. Ideally, we need reproductive material in January to plant in February, but often kelp is senesced by then. In recent years we've been able to grow bull kelp and keep it on surface, it behaves much like real kelp beds. Environmental monitoring arrays have instruments measuring temperature, salinity, PAR, DO, and pH data. We have an experiment at Port Angeles funded by WA Sea Grant for finding parameters of kelp growth with a reciprocal transplanting experiment with north/central Sound and hybrid individuals, measuring reproductive output and time of emergence of reproductive material, looking for any hybrid vigor and at what portions of genome are activated at different sites. In 2026, working with Samish on bed loss in SJC, testing methods used in Central and South Sound.

We also have a draft manuscript which is an evaluation of the population genetics study and variability of kelp throughout the region, looking at which parts of the genome are activated in different parts of the subbasin. There's a similar population genetics study with sugar kelp -looking at where there's genetic differentiation across the region.

QUESTIONS

Karin: How significant is the carbon sequestration factor, to what extent is that a real impact or is it overstated? Jodie: you didn't hear us talk about that at all – that's a clue. The amount provided by kelp/seaweeds is murky and it's much clearer that there's a biodiversity benefit. Focus should be on habitat benefits, water quality etc. Craig: you mentioned biodiversity benefits – are you looking at those in your study?

Jodie: yes, there's a great program called Reefcheck foundation. They use a standardized protocol throughout the region, they do four different types of surveys. We pair that with snorkel surveys. We have an ROV run by Zach

Randall from Seattle aquarium. Lots of ways to look at diversity underwater. It's important to do that both at restored site and paired adjacent wild bed so we can assess change. And it's clear – with habitat, the critters come. Emily: PSRF does restoration aquaculture which has similarities to commercial techniques, but the goals are different. I'd like to see more monitoring efforts at commercial farms to see their interactions with environment. Jodie: we've been working with famers in Vashon because DNR has asked that they have some monitoring program, the farmer in Colvos passage does Reefcheck surveys, similar work going on in Hood Head.

Tina: There are folks interested in farming in SJC with applications in the works. MRC should consider best practices so we can support aquaculture where appropriate and be clear about what specific siting means.

Emily: the second half of our paper sketches out considerations for best farming practices and what's needed for local research. It includes recommendations. There have been a couple farms going through this process with regulators. DNR has been actively thinking about this for a couple years.

Tina: unrealistic for every county's regulator to be kelp experts

Jodie: I would connect with folks from King County. And talk with the folks associated with permitting at Lummi Emily: but for siting, you'll be the best people for that because you know your local waters

Dave: Twofold question, issue of restoration vs. adaptation. Are the species the same inside the Salish sea and in Straits of Jaun de Fuca and outside? And what are your thoughts on ultimate causes on decline of kelp and the role of heat events in particular that aren't preventable? Can we accommodate with what species we put in? Jodie: yes, Nereocystis is the bull kelp and we're not seeing signs of subspeciation. If anything, there are a couple different ancestral groups but all the same species. To your second question, there is temperature tolerance – bull kelp don't like warm water. Above 16 C is like a seawater fire wall, bull kelp has trouble reproducing under those conditions. Nothing is static, there are places with persistent warmer water and kelp does fine there. How does genome activate differently in those areas to give that persistence advantage? We have new funding to look at that. Megan Dethier is doing a big study in causal factors. We can't cool down the water, but we can change nutrient inputs where those drive changes in conditions. What can we do on the terrestrial that can change the environment? What if we find that the kelp in Whidbey basin is the kelp that would be more tolerant everywhere? We don't want to weaken diversity over region, need to answer more questions about effect of hybridization Tina: Friends of the San Juans (2007) and Samish Indian Nation (2017) have ten years of data for bull kelp in SJC from work done with DNR showing 30% declines in the county.

Craig: The carbon storage/sequestration benefits from harvested commercial farms where the kelp biomass is removed from the ocean will be much less than natural beds where drift kelp detritus can sink into deep water, unless commercial kelp farming is harvesting and sinking/burying the kelp for carbon credits

Tina: Perhaps Megan Dethier could present to MRC about collaborative study into causal factors of kelp declines. Beth: I am curious what you've learned about competition between understory and bull kelp. How does competition affect site selection or success of restoration? are there collaborative restoration actions that balance the grazer/predator interactions to allow success?

Jodie: In some places, competition seems to be a factor, and in some places it doesn't. When it is an issue, it may be because the understory establishes first and creates a less-than-ideal situation for recruitment of canopy kelp (i.e., the kelp 'seed' doesn't have a place to land and grow). OR that both understory and canopy kelp are finding spaces to land, but then the understory species use the nutrients more quickly, leaving the bull kelp in the lurch. Beth: How does competition affect site selection or success of restoration? Or are there collaborative restoration actions that balance the grazer/predator interactions to allow success?

Jodie: we and others are trying to understand kelp crab predation better. Lots of kelp crab, and they love to eat kelp. Regarding competition - Megan Dethier's team is, as Tina mentioned, doing very cool work on understanding conditions during bull kelp emergence. Those results should shine light on the degree of competition/predation Kari Koski: are sea urchins still a problem without sea stars keeping them in check?

Jodie: Sea urchins are a big part of the downfall of kelp forests in CA, but not the main stressor here. We have our eyes on them! And the effect of the sea star die-off along the coast was certainly part of the CA story

10:09 AM Amy Carey from Sound Action presents:

With the introduction of commercial longline kelp aquaculture in marine waters of WA, aquaculture applicants are not required to get HPA permits but we at Sound Action have reviewed approximately 5,000 permits among broad regulatory processes. With permits that don't meet mandated standards, we want to participate in the process, provide information, last option is take legal action either administrative or judicial. I've lived on Vashon and worked on killer whales for 20 years, they come here in winter for chum runs. I've been part of the work group for orcas, looking at habitat loss. There has been interest in benefits of commercial aspects of kelp farming and plans to use long line arrays in the Sound, set horizontally/vertically. There's a significant amount of line going in the water. Entanglement is a real risk for large whales and for orcas, there's evidence of that from various sources. There's an application for a kelp farm commercial permit on the SW part of Vashon, highest whale use area. Southern residents, humpbacks, sometimes they're there for 45 days straight. We see cases where laws aren't being applied, e.g. starting with federal level, the Vashon applicant provided incorrect whale information – applicant said summer-was the whale-use time for orcas in this area and that there's limited use in fall and winter. And no mention of humpbacks. NMFS accepted that as fact throughout the process. This is especially critical for orcas that are close to extinction. We saw the same thing at King County level. Shoreline permits can take time, but applicants are excited to start on projects. A process that should have taken a year was pulled to the front of the line. For the biological evaluation they accepted a towed video from the applicant, not a biologist, not in correct season. Very little opportunity for public comment, fast tracked process but the permit was still allowed to go in directly over native vegetation despite comment letters and some participation. At the State DNR level, many efforts to try to bring some better information in. There's native bull kelp adjacent to this site. Rather than a 12year lease, they issued four years.

I mentioned before that our last resort is legal action -an appeal on this is still in process. There is no monitoring requirement, no reporting about whales, no parameters in permitting or leasing to stop work if whales are entangled.

We're not opposed to kelp farming, but we need to get this right. Both for the whales and for the emerging industry.

We've started talking to entities early on and developed this 'hold the line' campaign – we want to ensure these farms aren't sited in high whale use areas. And there are alternatives to using rope – i.e. fiberglass structures that wouldn't entangle. Siting in shallow areas away from whale-use. We brought forward a body of information about weak-link/breakaway lines. We've been mapping from available datasets, we know where high whale-use areas are.

Local experts (Amy provides names) have noted the risk of entanglement. Tighter lines are not an avoidance and wouldn't prevent a whale's weight from disturbing lines. Another issue ignored by regulatory agencies is "kelping" – whales are attracted to kelp. Bringing these issues up to highlight what's happening in regulatory process, and where we see problematic gaps. As the MRC you have a unique opportunity as projects are being proposed in SJ's. The lease for the farm in SW Vashon was granted despite the case in court. We've confirmed presence of whales next to buoys of the new farm, even though all lines aren't in yet. Need improvements in the industry. QUESTIONS:

Adam: Which is the regulatory group or organization making these faulty decisions?

Amy: All of them. With whale data the Army Corps, King County with shoreline permitting and DNR for leasing Frankie: there was a presentation this week regarding the orca occupancy model that is being built and will be used for the orca indicator, I think that will have benefit to these real-life with permitting. Not all that siting is necessarily getting into the databases that regulators see when they put those permits together. It's a more complicated question of how to get more comprehensive siting databases available for these purposes.

Amy: We have this body of information and different technology, we used various databases in our own mapping Frankie: more about available databases, it's important to be wary of pseudo replication if you're just mapping from public sightings directly. The Whale Museum is collating from a lot of different sources.

Lovel: if we consider making recommendations to the County in terms of their role in permitting process it would be helpful if there's anything in writing that would summarize your recommendations, if you could send that to Sam

Dave: there's been a tribal representative, Patti Gobin. The best way is to have a person at the table Mike: with 14 different tribes! I've worked with most of them. we are on their land for most of what we do Frankie: It's a process because every Tribe is different, so we'll engage with each Tribe as much as they wish. I can share the Tribal engagement framework that was approved by Council a couple weeks ago. I can also send out the training parts 1 & 2 that were super helpful. I'd love to have the NWIC come talk to the MRC about new initiatives. Adam: then can we make it a monthly update that happens at the MRC meeting?

Frankie: The stewardship group is a subcommittee, there's a good opportunity to engage the Stewardship network tribal engagement group. That's about elevating tribal events that happen here, celebrating native awareness month – like the screening of the Fish wars movie. The MRC is meant to have a Tribal rep on the committee. In terms of understanding the government-to-government relationship we need to make sure we do things right

capacity. But we need to avoid actions/projects that Tribes don't even know about ACTION: Frankie will talk to Patti about this before the January MRC meeting ACTION: members that are present will check with members that aren't present, meet as a subcommittee to decide what to do going forward, this will be on agenda for January ACTION: Sandy will check with Jeff Dyer about remaining on the subcommittee as a citizen member *Committee members*: Patti G., Christina K., Jeff D., Kendra S., Mike R., Sandy W.E.

5. Oil Spill Prevention and Response Preparedness/ERTV

We've merged these two subcommittees into one, ERTV planning is a measure for oil spill prevention MOTION: Mike moves to combine these two subcommittees, Karin seconds. All in favor, the motion passes. Marta: Efforts in the County have been stymied due to Ecology's report on the oil spill risk assessment. The subcommittee's work has helped inform the County, but the report's results were damaging and misleading. They averaged the risk across the Salish Sea and diverted efforts to get more of a voice here and in Canada to solidify this message. I offered you all a final review of Ecology's report; we still have unresolved questions; we need to rely on the work that's been done in Canada and by NUCA study that we commissioned to come together with Islands Trust (who Cindy met with yesterday together with County Council). I encourage the MRC to get behind that movement, we've been at this for 10 years. Please help educate the new council on this. Governor Inslee wants to talk about this with Canada before he leaves office at the end of this month. The County's decade-long efforts in support of an ERTV were put on hold by Ecology's 4-yr modeling project. This year the ERTV subcommittee has accomplished much to inform the County's inquiries to Ecology, yet many concerns of the misleading conclusions and implausible results (Sidney v RH) remain unresolved. Let's put a pin in the Ecology report with the updated 1-pager on our review and findings. The point is not to let Ecology detract from all the support for an ERTV. We heard from Islands Trust yesterday that they could support a Joint statement with First Nations to Transport Canada. I hope the MRC will seek Tribal, elected and other partners for such a joint statement as a matter of urgency.

Lovel: thank you Marta for your tenacious work on this. Let's draft some outreach materials for the Council to use in their advocacy of an ERTV. We have two new council members and we're losing an important advocate with Cindy.

Marta: Senator Cantwell's and the Governor's offices have been reliant on the Ecology report. So, please look at the one-pager I've produced to say we acknowledge the work that's been done. We can say, 'this is what the Ecology report provided and this what it didn't do', but meanwhile still need to show the importance of an ERTV. Adam: do we have an action item for January to have those one-pagers ready to send out? Lovel: the staff has Marta's one-pager and the other handout we've been using. Now those need to be put togeth-

er ACTION ITEM: For January meeting we'll have a draft presented that we can review to send to Council Cindy: We must keep Marta's information circulating and use it to educate. Ecology won't change the report, and they don't want to be criticized for it, but they are on the same page about wanting a ERTV. So now it's about how to move forward to get acknowledgement that the ERTV is needed. Ecology will cooperate, but not by retracting that report.

Craig: we can highlight the part of the report that showed zones around the SJI's and directly connected waterways. That part does strongly support an ERTV so we can use this report to our advantage even without being critical

Dave: would Ecology co-sign a letter from the MRC to the Governor's office advocating for an ERTV? Cindy: Ecology's position is about how narrow a question was asked, and they addressed that question. But this is a marathon, it's not a time to give up. I don't know if a statement from Ecology would be enough. I think it's about getting the attention of the new governor and getting him involved as an advocate himself Adam: the first step is agreeing as an MRC about the information we want to send up the ladder

Cindy: also with new Council members coming in, putting together a comprehensive briefing for them. Kari McVeigh and Jane fuller – get on their calendar and give them a compendium of all the materials that have been developed Marta: I appreciate that Ecology is saying don't rely on the report, but the fact that it devalues the presence of an ERTV in Sidney is a major impediment. That's wrong and it's a big problem. I just hope everyone in this room has a sense of urgency about this, to work with Canadians and Tribal partners Lovel: we are an advisory committee to the Council, so we'll be sending the necessary information to them Frankie: and there's still value in the report we had done, we can focus on the results of our report Adam: let's table this discussion and see what he subcommittee comes up with for January

Committee members: Lovel P., Christina K, Matt A., Craig S., David C., Brian G., and Marta G. as member of public

6. Marine Stewardship

We can disband this committee because the MSA is done. MOTION: Lovel moves to disband this subcommittee, Beth seconds. All in favor. Yay Frankie!

7. Outreach

Sandy: we met, and we reported earlier about the subcommittee Sandy will take lead on that subcommittee, he'll work with Katie *Committee members*: Sandy W.E., Kailey G., Beth T., Adam P., Pema K.

8. Vessel Surveys/Benthic Habitat Project

Sam: These two projects were funded with NOAA federal funding, these can fall under the submerged vegetation subcommittee discussion. Majority of field work completed in 2024, we can report more on these in the new year Mike: in terms of the OPMA, for the subcommittees, since there's no quorum, we don't need to consider? Discussion: the subcommittees don't make decisions, they gather information and advise the MRC. Lovel: but subcommittees can be subject to OPMA if involve other MRC members inadvertently to create quorum Question: can subcommittees vote on something or just discuss it? - they come to consensus, but not a formal vote Kari: some of the activities are confusing for DV because they overlap with paid staff activities Craig: the PFFS does a lot of actions. Do all of those decisions need to get run by the MRC? Adam: it should be every month when we meet, each subcommittees reports on what they've been doing and what they'd like to do in the next month. Action items don't necessarily need to be voted on, just more communication at each monthly meeting about what each subcommittee is doing

Karin: one more thing, to create a subcommittee for DEI. There are underserved members in our community MOTION: Sandy moves to create a DEI subcommittee, Dave seconds. All in favor. That's a new subcommittee ACTION ITEM: Karin will give a briefing about that in the January meeting and then we can add members Marta: Ecology senior management came to Friday Harbor to present to Council in June on Oil Spill Prevention. Any mention of their ERTV study was absent. We had no notice - A missed opportunity for ES and MRC members to engage with Ecology on oil spill prevention and ERTV to reduce risk. Ecology isn't standing behind their study so we should be clear that we don't (especially in international discussions)
